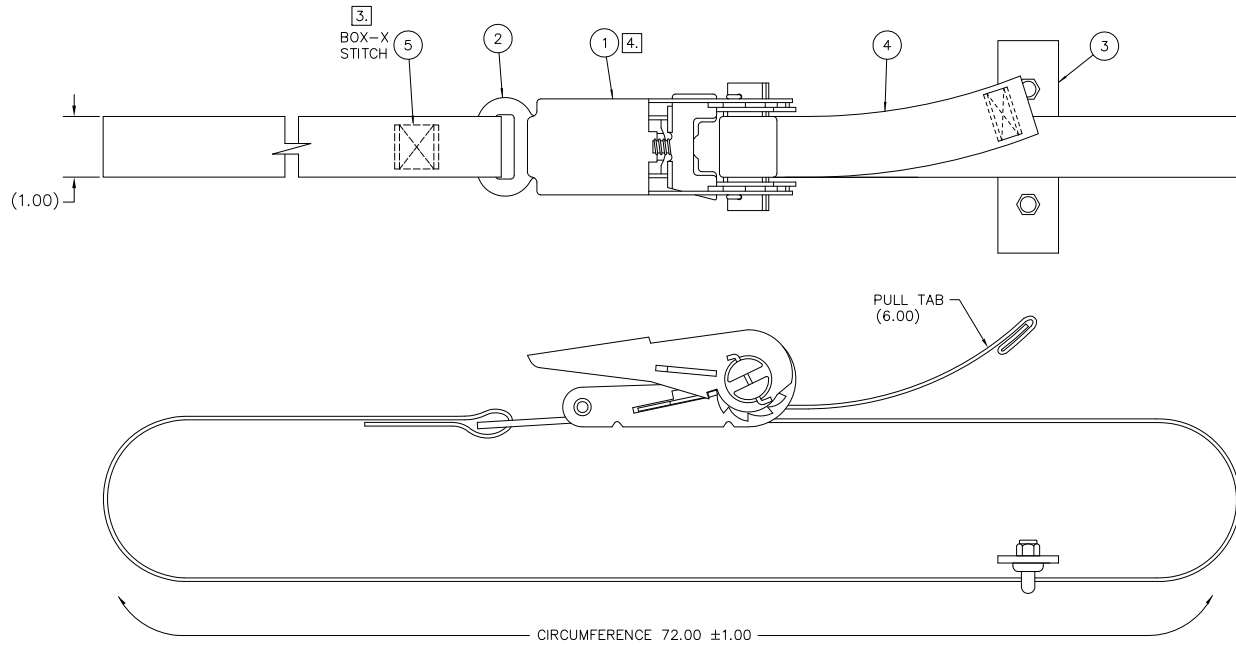

1. MINIMUM TENSILE BREAKING STRENGTH OF COMPLETE ASSEMBLY SHALL BE 1200 POUNDS. SAFE WORKING LOAD, 400 POUNDS MAXIMUM.
2. WEBBING ENDS SHALL BE SEALED BEFORE STITCHING.
3. STITCHING SHALL BE IAW FED-STD-751, TYPE 301. STITCH PATTERN SHALL BE SUFFICIENT TO MEET THE REQUIREMENTS OF NOTE 1 ABOVE.
4. FASTENER SHALL BE A RATCHET TYPE DEVICE THAT APPLIES TENSION TO WEBBING WHEN MANUALLY OPERATED.
5. FINISH: STEEL COMPONENTS, ZINC PLATED, BRONZE OR CLEAR CHROMATE.
