

- 5. PERFORMANCE:
- 5.1 TEMPERATURE:
- 5.1.1 OPERATING RANGE: -25°C TO +60°C
- 5.1.2 ACCURACY: ±1°C WITHIN OPERATING RANGE.
- 5.2 HUMIDITY:
- 5.2.1 OPERATING RANGE: 0%RH TO 100%RH CONDENSING
- 5.2.2 ACCURACY: ±2%RH TYPICAL BETWEEN 20%RH AND 80%RH AT 25°C. TYPICAL LONG-TERM DRIFT <0.25%RH/YEAR.

- 6. DESCRIPTION OF OPERATION:
- 6.1 DEVICE LOGS TEMPERATURE AND RELATIVE HUMIDITY ONCE PER HOUR. DATA RECORD IS DOWNLOADABLE IN CSV FORMAT VIA INTERROGATOR TOOL WITHOUT REMOVAL OF THE DEVICE FROM CONTAINER
- 6.2 STATUS LED ACTIVATED BY PUSHBUTTON WINDOW OR BY HANDHELD ACTIVATOR. LED FLASHES RED IF PRE-SET THRESHOLD HAS BEEN EXCEEDED AND ILLUMINATES SOLID GREEN IF THE THRESHOLD HAS NOT BEEN EXCEEDED. THRESHOLD IS A USER-SETTABLE NUMBER OF CONSECUTIVE READING ABOVE A USER-SETTABLE %RH. THRESHOLD IS PROGRAMMABLE VIA INTERROGATOR TOOL.
- 6.3 DEVICE IS RESETTABLE VIA INTERROGATOR TOOL.
- 6.3.1 SOFT RESET: RESETS THE LED FROM RED TO GREEN. DOES NOT DELETE DATA RECORD.
- 6.3.2 HARD RESET: RESETS THE LED FROM RED TO GREEN, DELETES THE DATA RECORD, AND PUTS THE DEVICE TO SLEEP UNTIL REACTIVATION BY HANDHELD ACTIVATOR.
- 6.4 HUMIDITY ENTERS DEVICE THROUGH HUMIDITY PORTS. PORTS MUST REMAIN OPEN TO ENVIRONMENT BEING MONITORED.
- 6.5 HUMIDITY INDICATOR CARD PROVIDES A PASSIVE BACKUP TO ELECTRONIC MONITORING.
